ABCs

Conduct


What are Ethics?

ABCs

This is the practical application of your attitude and beliefs, basically where the rubber hits the road. What do you say & do, how do you engage in any given situation – personally, professionally, organizationally? How do you achieve balance? How do you manage goals, realities and imperatives when reaching a "best case" decision?

Ethics Committees Inform & Support:

- Organizational Effectiveness
 - Compliance
 - Conflict Management
 - Education & Outreach
 - Policies & Procedures
- Consistency of Ethical Practice

Ethics Committees

Composition

Members

- Committee Chair
- Legal Counsel
- Ethics Advisor**
- Staff
- External Stakeholders, such as program participants, business/community leaders, health & safety professionals, educators, HR representative, ad hoc members with specific knowledge of a given situation

**A local hospital, college, or university may have an ethicist willing to fulfill this role

The Scenario

The County Problem Solving Court contracts with your organization to provide Recovery Coach services. Carla, one of your seasoned coaches has been working with Lauren for 18 months. Lauren has successfully completed all stages and tasks up to this point; she currently holds a job and attends the local community college. Just before her routine urine screening, Lauren discloses she used marijuana once during the previous week. Court policy mandates an immediate return to a 90-day rehab stay in cases of relapse. Carla does not believe this is in Lauren's best interest at all. What should she do?
